

AMENDMENT NO. 2 TO THE SERVICES AGREEMENT BETWEEN THE CITY OF VERNON AND UNIVERSAL BUILDING MAINTENANCE, LLC DBA ALLIED UNIVERSAL JANITORIAL SERVICES FOR CONTRACT NO. CS-1414: JANITORIAL SERVICES

This Amendment No. 2 (Amendment) to the Agreement for janitorial services dated January 1, 2022, (Agreement), is made as of January 16, 2024, by and between the City of Vernon, a California charter city and municipal corporation (City), and Universal Building Maintenance, LLC dba Allied Universal Janitorial Services (Contractor), a California corporation.

The City and Contractor agree as follows:

RECITALS

- A. The City and Contractor are parties to a written Agreement dated January 1, 2022, under which Contractor provides janitorial services.
- B. The City and Contractor desire to amend the Agreement to extend the Agreement for an additional one-year period effective January 1, 2024, for a total amount not to exceed \$146,163.00. A copy of the correspondence dated January 1, 2024, provided by Contractor is attached hereto as Exhibit A.

NOW, THEREFORE, the parties to this Amendment agree as follows:

- 1. The Agreement has been renewed for an additional one (1) year period, and the Termination Date listed on the Cover Page and Section 4.0 of the Agreement is changed to December 31, 2024.
- 2. Contractor's grand total consideration for the renewal term of this Amendment, from January 1, 2024 to December 31, 2024, shall not exceed the amount of One Hundred, Forty-Six Thousand, One Hundred and Sixty-Three Dollars (\$146,163.00), without prior City Council approval and written amendment of the Agreement.
- 3. Except as expressly modified by this Amendment, all provisions of the Agreement shall remain in full force and effect.
- 4. The provisions of this Amendment shall constitute the entire agreement of the parties with respect to the subject matter included in this Amendment and shall supersede any other agreement, understanding, or arrangement, whether written or oral, between the parties with respect to the subject matter of this Amendment.
- 5. The person or persons executing this Amendment on behalf of each of the parties warrants and represents that he or she has the authority to execute this Amendment on behalf of that party and has the authority to bind that party to the performance of its obligations hereunder.
